Sir,

Reference your application for approval to conduct medical examination at the address given in para 2 below at Dehradun. - 3. Validity is subject to the condition that the medical examination of seafarers shall be conducted in accordance with provisions of Merchant Shipping (Medical Examination Rules 2000) and DGS orders/Notices issued from time to time. Necessary facilities required for conduct of medical examination and relevant publications are maintained at all times at the clinic.
- 4. Records of all medical examinations shall be maintained for a period of three years. The records should be available for verification as and when required by the Competent Authority or the officials of the Directorate/Mercantile Marine Department.
- 5. Prior approval of the Competent Authority is to be obtained in case of any change regarding the place of conduct of medical examination or if any other deviation is made.
- 6. Any investigations required to be undergone by the seafarers for the purpose of medical examination needs to be undertaken at the Medical Laboratory recognized/approved by the appropriate authorities of the respective State.
- 7. The Medical Examiner shall abide by all the orders/guidelines and circulars governing the sanction/appointment/approval thereof published in the official website of the Directorate viz. <a href="https://www.dgshipping.gov.in">www.dgshipping.gov.in</a>, in the act of such publication being enough evidence of the said orders/guidelines and circulars have been published.
- 8. The Medical Examiner shall maintain standards of excellence and professionalism in all matters relating to conduct of medical examination of seafarers in terms of guidelines issued by this Directorate.
- 9. The appointment/approval of Medical Examiner is also subject to necessary approval from local bodies, State Government including trade and labour regulations, municipal authority and other such authorities as may be applicable and clear possession of the place, wherein the medical examination of seafarers are conducted.
